# What carriers need to know about ACI eManifest

EDI transmission of highway cargo and trip data must be received and validated by the CBSA no later than one hour before arrival at FPOA.

All cargo data must be accepted by CBSA and on file in order to be subsequently linked to a trip. If a trip is transmitted quoting a cargo control number that is either not on file or in reject status, the trip will be rejected.

EDI highway cargo and trip data may be presented up to 30 days before arrival. If either the cargo or trip is not to be used, the carrier should transmit a delete for that cargo or trip data.

The Cargo Control Number (CCN) and Trip Number cannot be the same, even if there is only one cargo on the trip. These numbers must not be duplicated for a three-year period (plus current year).

The eManifest must be submitted and accepted by CBSA prior to the approval of the brokers entry transaction. Failure to do so, will result in the PARS not being on file when the carrier arrives at the border.

Also, ACI eManifest regulations require one PARS per shipper to one consignee. Multiple consignees or drops require multiple PARS when not consolidated.

In the event there are changes to the submitted eManifest (for example, truck breakdown necessitated a change of vehicle, or the driver became ill and was replaced), the eManifest must be revised and the operator/driver must be provided a revised e-Manifest. The date need not be changed, as it is valid up to 30 days.
